**In the First Four Months of 2020,
Net Generation of Subsidiary Power Plants Decreased by 7.1%,
among which Subsidiary Wind Farms Increased by 27.0%**

Total net generation of subsidiary power plants in April 2020 decreased by 5.0% year on year to 10,903,732MWh, among which, subsidiary wind farms increased by 20.5% year on year to 1,954,451MWh.

Total net generation of subsidiary power plants for the first four months of 2020 decreased by 7.1% year on year to 44,286,727MWh, among which, subsidiary wind farms increased by 27.0% year on year to 7,140,171MWh.
