Net Generation of Subsidiary Power Plants Increased by 22.1%,
among which Wind Farms Increased by 53.8%,
Photovoltaic Plants Increased by 62.3%**

Total net generation of subsidiary power plants in July 2021 increased by 19.5% year on year to 16,106,778MWh, among which, subsidiary wind farms increased by 85.5% year on year to 2,441,192MWh, subsidiary photovoltaic plants increased by 97.1% year on year to 123,754MWh.

Total net generation of subsidiary power plants for the first seven months of 2021 increased by 22.1% year on year to 102,211,903MWh, among which, subsidiary wind farms increased by 53.8% year on year to 18,547,830MWh, subsidiary photovoltaic plants increased by 62.3% year on year to 683,841MWh.
