## Net Generation of Subsidiary Power Plants in the First Five Months of 2018 Increased by 5.3%

China Resources Power Holdings Company Limited ("CR Power", stock code: 0836) today announced that total net generation of subsidiary power plants in May 2018 increased by 2.8% to 11,991,121MWh from 11,660,678MWh for the same period of 2017.
